E. Notes to the condensed interim consolidated financial statements

1. Corporate information

Captii Limited (the company) is incorporated in Singapore with limited liability. It is listed on Singapore Exchange Securities Trading Limited ("SGX-ST"). These condensed interim consolidated financial statements as at and for the financial period ended 30 June 2023 comprise the company and its subsidiaries (collectively, the group). The primary activities of the company are those of investment holding and the provision of management services.

The principal activities of the group are:

- a) Distribution of information technology and telecommunications products, research and development, software engineering, system integration, project management, and maintenance and support services for the telecommunications industry.
- b) Providing money lending services, credit profiling, pay-later solutions, and/or other incidental/relevant businesses to any telecommunications operators, service providers, enterprises, or entities of any descriptions.
- c) Provision of global roaming quality of services management solutions.
- d) Undertake investment in technology companies.
- e) Investment holding and the provision of management services

2. Basis of Preparation

The condensed interim financial statements for the financial period ended 30 June 2023 have been prepared in accordance with SFRS(I) 1-34 Interim Financial Reporting issued by the Accounting Standards Council Singapore. The condensed financial statements do not include all the information required for a complete set of financial statements. However, selected explanatory notes are included to explain events and transactions that are significant to an understanding of the changes in the group's financial statements for the year ended 31 December 2022.

The accounting policies adopted are consistent with those of the previous financial year which were prepared in accordance with SFRS(I)s, except for the adoption of new and amended standards as set out in Note 2.1.

The condensed interim financial statements are presented in Singapore dollar which is the company's functional currency.

2.1. New and amended standards adopted by the group

A number of amendments to Standards have become applicable for the current reporting period. The group did not have to change its accounting policies or make retrospective adjustments as a result of adopting those standards.

2.2. Use of judgements and estimates

In preparing the condensed financial statements, management has made judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets and liabilities, income and expense. Actual results may differ from these estimates.

The significant judgements made by management in applying the group's accounting policies and the key sources of estimation uncertainty were the same as those that applied to the consolidated financial statements as at and for the year ended 31 December 2022.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimates are revised and in any future periods affected.

Information about critical judgements in applying accounting policies that have the most significant effect on the amounts recognised in the financial statements is included in the following notes:

* Note 12 - Classification of investment property

Information about assumptions and estimation uncertainties that have a significant risk of resulting in a material adjustment to the carrying amounts of assets and liabilities within the next interim period are included in the following notes:

- * Note 9 fair value of unquoted investments
- * Note 10 impairment test of intangible assets and goodwill: key assumptions underlying recoverable amounts
- * Note 12 determination of fair value of investment property using significant unobservable inputs

3. Seasonal operations

The group's businesses are not affected significantly by seasonal or cyclical factors during the financial period.

4. Segment and revenue information

The group is organised into the following main business segments:

- * Unifiedcomms Segment for content-driven mobile VAS, messaging and signaling systems, solutions and managed services.
- * GlobeOSS Segment for mobile network operation support systems, solutions and managed services.
- Captii Ventures Segment for strategic investment in early and late-stage technology ventures.
- * Others Segment for investment holding and operational headquarters of the group.

These operating segments are reported in a manner consistent with internal reporting provided to those who are responsible for allocating resources and assessing performance of the operating segments.

4.2. Disaggregation of revenue

The group's revenue can be divided into revenue generated from two types of contracts, as described below:

- (a) System sales this refers to contracts that involve the outright purchase by customers of systems comprising the group's products and technologies, and where these systems are in turn delivered as turnkey solutions. The scope of work for a system sale contract includes system design, implementation, testing and commissioning services.
- (b) Managed services this refers to contracts that involve the provision of both systems comprising the group's products and technologies as well as the group's professional services, on a recurring, revenue sharing, softwareas-a-service, pay-per-use or monthly or quarterly fixed and variable fee basis. Also treated as managed service contracts are system maintenance and technical support contracts with existing customers of the group.

1. Review

The condensed consolidated statement of financial position of Captii Limited and its subsidiaries as at 30 June 2023 and the related condensed consolidated profit or loss and other comprehensive income, condensed consolidated statement of changes in equity and condensed consolidated statement of cash flows for the financial period ended and certain explanatory notes have not been audited or reviewed.

2. Review of performance of the group

2.1 Review of performance of the group for the second quarter ended 30 June 2023 as compared to corresponding quarter ended 30 June 2022

Group revenue

The group recorded consolidated revenue of S\$5.127 million for the quarter ended 30 June 2023 ("Q2 2023"), a 4.2% decrease against the revenue recorded in the corresponding quarter ended 30 June 2022 ("Q2 2022"). The decline in group revenue for Q2 2023 is attributable to lower revenue recorded by Unifiedcomms.

Unifiedcomms recorded revenue of S\$3.201 million in Q2 2023, a decrease of 17.2% from the S\$3.864 million recorded in Q2 2022. This decrease in revenue was due to lower managed service contract revenues.

In contrast, GlobeOSS posted revenue of \$\$1.926 million in Q2 2023, an increase of 29.3% from the \$\$1.49 million recorded in Q2 2022. This improvement in revenue was mainly driven by higher system sale contract revenues.

The group's sales mix in Q2 2023 showed a decrease in the proportionate contribution of revenue of a recurring nature, with revenue from managed service contracts representing 65.1% of the group's total revenue in Q2 2023 as compared to 79.9% in Q2 2022. The lower relative contribution of managed service contracts to the group's sales mix in Q2 2023 is mainly attributable to the improvement in system sale contract revenues of the group, which had improved 66.6% from S\$1.076 million in Q2 2022 to S\$1.793 million in Q2 2023.

Group gross profit and gross profit margins

With the lower revenue recorded in Q2 2023, the group recorded lower gross profit of S\$2.089 million, a decrease of 21.5% from the S\$2.66 million realised in Q2 2022. In addition, gross profit margin had decreased from 49.7% in Q2 2022 to 40.7% in Q2 2023.

The decrease in group gross profit margin is mainly attributable to the lower gross profit margin recorded on the group's system sale contract revenues, which decreased to 34.7% in Q2 2023 from 73.3% in Q2 2022. This decrease in gross profit margin was mainly due to the higher proportionate contribution of system sale contract revenues by GlobeOSS, which generally yield lower gross profit margin as a result of its typically higher third party costs.

The gross margin impact from the above system sale contracts was partly mitigated by the higher gross profit margin on managed service contract revenues of 44% in Q2 2023, versus the 43.7% recorded in Q2 2022. This improvement in managed service contract gross profit margin is attributable to the lower revenue contribution of certain lower-margin managed service contracts.

Interest income

The group recorded interest income of S\$0.031 million in Q2 2023, flat against what was recorded in Q2 2022.

Other gains and other item of expense

The group recorded net total expenses of S\$1.848 million in Q2 2023, 8% lower than the S\$2.009 million incurred in Q2 2022. This is mainly attributable to the:-

- * Lower fair value loss of \$\$0.019 assessed on the group's venture investment portfolio in Q2 2023 as compared to fair value loss of \$\$0.156 million recorded in Q2 2022;
- * Higher net foreign exchange gain as a result of favourable exchange rate movement of MYR against SGD, the group's reporting currency, and
- * Lower administrative expenses recorded in Q2 2023, in relation to lower corporate personel costs.

The above improvement was partly offset by higher technical support expenses and distribution costs, due to an increase in headcount at both GlobeOSS and Unifiedcomms.

Net profit and EBITDA

The group recorded lower net profit of \$\$0.206 million and EBITDA of \$\$0.496 million in Q2 2023 as compared to \$\$0.561 million in net profit and \$\$0.94 million in EBITDA recorded in Q2 2022. The lower net profit and EBITDA results recorded in Q2 2023 are mainly attributable to the flow-down effects of lower revenue and lower gross profit margin, though partly mitigated by lower net total expenses.

2.2 Review of performance of the group for the six months ended 30 June 2023 as compared to corresponding financial period ended 30 June 2022

Group revenue

The group recorded consolidated revenue of S\$10.188 million for the six months ended 30 June 2023 ("6M 2023"), a 4.8% decrease against the revenue recorded in the corresponding period ended 30 June 2022 ("6M 2022"). The decline in group revenue for 6M 2023 is attributable to lower revenue recorded by Unifiedcomms.

Unifiedcomms recorded revenue of S\$6.337 million in 6M 2023, a decrease of 15.9% from the S\$7.534 million recorded in 6M 2022. This decrease in revenue was due to lower managed service contract revenues.

In contrast, GlobeOSS posted revenue of \$\$3.851 million in 6M 2023, an increase of 21.7% from the \$\$3.164 million recorded in 6M 2022. This improvement in revenue was mainly driven by higher system sale contract revenues.

The group's sales mix in 6M 2023 showed a decrease in the proportionate contribution of revenue of a recurring nature, with revenue from managed service contracts representing 66.9% of the group's total revenue in 6M 2023 as compared to 81.9% in 6M 2022. The lower relative contribution of managed service contracts to the group's sales mix in 6M 2023 is mainly attributable to the improvement in system sale contract revenues of the group, which had improved 73.9% from S\$1.938 million in 6M 2022 to S\$3.37 million in 6M 2023.

Gross profit and gross profit margins

With the lower revenue recorded in 6M 2023, the group recorded lower gross profit of S\$4.419 million, a decrease of 14.3% from the S\$5.159 million realised in 6M 2022. In addition, gross profit margin had decreased from 48.2% in 6M 2022 to 43.4% in 6M 2023.

The decrease in group gross profit margin is mainly attributable to the lower gross profit margin recorded on the group's system sale contract revenues, which decreased to 42.3% in 6M 2023 from 70.6% in 6M 2022. This decrease in gross profit margin was mainly due to the higher proportionate contribution of system sale contract revenues by GlobeOSS, which generally yield lower gross profit margin as a result of its typically higher third party costs.

The gross margin impact from the above system sale contracts was partly mitigated by the higher gross profit margin on managed service contract revenues of 43.9% in 6M 2023, versus the 43.3% recorded in 6M 2022. This improvement in managed service contract gross profit margin is attributable to the lower revenue contribution of certain lower-margin managed service contracts.

Interest income

The group recorded interest income of S\$0.064 million in 6M 2023, flat against what was recorded in 6M 2022.

Other gains and other item of expense

The group recorded net total expenses of S\$4.087 million in 6M 2023, 4.8% higher than the S\$3.9 million incurred in 6M 2022. This is mainly attributable to the higher technical support expenses and distribution costs, due to an increase in headcount from GlobeOSS.

The above impact was partly mitigated by lower administrative expenses recorded in 6M 2023, in relation to lower corporate personnel costs

Net profit and EBITDA

The group recorded lower net profit of \$\$0.299 million and EBITDA of \$\$0.842 million in 6M 2023 as compared to \$\$1.093 million in net profit and \$\$1.864 million in EBITDA recorded in 6M 2022. The lower net profit and EBITDA results recorded in 6M 2023 are mainly attributable to the flow-down effects of lower revenue, lower gross profit margin and bitcher net total expenses.

2.3 Review of the group's financial position as at 30 June 2023 as compared to the group's financial position as at 31 December 2022

Non-cash current assets of the group decreased from S\$14.65 million as at 31 December 2022 to S\$13.471 million as at 30 June 2023. This 8.1% decrease in non-cash current assets was mainly due to a decrease in trade and other receivables as a result of lower revenue recorded.

Total non-current assets of the group decreased from S\$35.261 million as at 31 December 2022 to S\$34.686 million as at 30 June 2023. This decrease of 1.6% in non-current assets is attributable to:-

- * On-going depreciation charges on plant and equipment; and
- * Reduction in value of the group's MYR denominated intangible assets and investment property due to foreign exchange movements.

Total liabilities of the group decreased from S\$6.427 million as at 31 December 2022 to S\$4.137 million as at 30 June 2023. This 35.6% decrease in total liabilities is attributable to the decrease in trade and other payables following repayments made in the reporting period.

2.4 Review of the group's cash flow for the quarter and six months ended 30 June 2023 as compared to the corresponding quarter ended 30 June 2022

The group's net cash flow from operations for Q2 2023 was S\$1.32 million, as compared to S\$0.643 million for Q2 2022. This increase was primarily due to a favourable change in working capital of S\$0.805 million for Q2 2023, in contrast with the unfavourable change in working capital of S\$0.453 million for Q2 2022. This improvement was mainly due to lower repayment of trade and other payables for Q2 2023 as compared to Q2 2022.

The group's net cash flow from operations for 6M 2023 was S\$1.069 million, as compared to S\$0.034 million for 6M 2022. This significant increase was primarily due to a favourable change in working capital of S\$0.207 million for 6M 2023, in contrast with the unfavourable change in working capital of S\$1.851 million for 6M 2022. This improvement was mainly due to lower repayment of trade and other payables for 6M 2023 as compared to 6M 2022.

The group's net cash flow used in investing activities for Q2 2023 was S\$0.222 million, as compared to S\$0.173 million recorded in Q2 2022. The higher net cash used in investing activities was mainly due to the higher volume of venture investments made in the current quarter as compared to Q2 2022.

The group's net cash flow used in investing activities for 6M 2023 was S\$0.319 million, in contrast with the net cash flow from investing activities of S\$1.253 million in 6M 2022. This was primarily due to absence of proceeds from the disposal of a venture investment in 6M 2022.

The group's net cash flow used in financing activities for Q2 2023 amounted to S\$0.818 million as compared to S\$0.199 million for Q2 2022. The higher net cash used in financing activities was mainly due to higher repayment of borrowings in Q2 2023.

The group's net cash flow used in financing activities for 6M 2023 amounted to S\$1.077 million as compared to S\$0.665 million for 6M 2022. The higher net cash used in financing activities was mainly due to higher repayment of borrowings in 6M 2023.

No profit forecast has been issued for the financial period under review.

4. A commentary at the date of the announcement of the significant trends and competitive conditions of the industry in which the group operates and any known factors or events that may affect the group in the next reporting period and the next 12 months.

The risk and uncertainty of the economy going into recession due to geo-political tensions, supply chain disruption, and rising inflation and interest rates, especially in the group's regions of focus, have weighed on the minds of management and the directors of the group when considering the outlook for the remainder of the financial year.

The operations of Unifiedcomms and GlobeOSS in the financial year under review had been minimally impacted by geo-political tensions and supply chain disruption. On the business front, both Unifiedcomms and GlobeOSS contracts in-hand continue to be progressed and management of the group are hopeful that new projects and initiatives requiring our products and services, will continue to be pursued by customers. The possibility remains however, that larger system sale contracts that have yet to be committed in the financial year under review, may be further deferred, or even abandoned entirely if macroeconomic and industry conditions worsen or do not improve significantly enough.

At Captii Ventures, the group's venture investment business, the climate for business development and funding continues to be challenging for start-ups in certain industries.

Against this negative but improving macroeconomic backdrop for the future, the group remains optimistic and will continue to work closely with customers and investees, to minimise the negative impact of economic uncertainty on group financial performance.
