E. Notes to the condensed interim consolidated financial statements

1. Corporate information

Captii Limited (the company) is incorporated in Singapore with limited liability. It is listed on Singapore Exchange Securities Trading Limited ("SGX-ST"). These condensed interim consolidated financial statements as at and for the financial period ended 30 September 2025 comprise the company and its subsidiaries (collectively, the group). The primary activities of the company are those of investment holding and the provision of management services.

The principal activities of the group are:

- a) Distribution of information technology and telecommunications products, research and development, software engineering, system integration, project management, and maintenance and support services for the telecommunications industry.
- b) Providing money lending services, credit profiling, pay-later solutions, and/or other incidental/relevant businesses to any telecommunications operators, service providers, enterprises, or entities of any descriptions.
- c) Provision of global roaming quality of services management solutions.
- d) Undertake investment in technology companies.
- e) Investment holding and the provision of management services.

2. Basis of Preparation

The condensed interim financial statements for the financial period ended 30 September 2025 have been prepared in accordance with SFRS(I) 1-34 Interim Financial Reporting issued by the Accounting Standards Council Singapore. The condensed financial statements do not include all the information required for a complete set of financial statements. However, selected explanatory notes are included to explain events and transactions that are significant to an understanding of the changes in the group's financial position and performance of the group since the last annual financial statements for the year ended 31 December 2024.

The accounting policies adopted are consistent with those of the previous financial year which were prepared in accordance with SFRS(I)s, except for the adoption of new and amended standards as set out in Note 2.1

The condensed interim financial statements are presented in Singapore dollar which is the company's functional currency.

2.1. New and amended standards adopted by the group

A number of amendments to Standards have become applicable for the current reporting period. The group did not have to change its accounting policies or make retrospective adjustments as a result of adopting those standards.

2.2. Use of judgements and estimates

In preparing the condensed financial statements, management has made judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets and liabilities, income and expense. Actual results may differ from these estimates.

The significant judgements made by management in applying the group's accounting policies and the key sources of estimation uncertainty were the same as those that applied to the consolidated financial statements as at and for the year ended 31 December 2024.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimates are revised and in any future periods affected.

Information about critical judgements in applying accounting policies that have the most significant effect on the amounts recognised in the financial statements is included in the following notes:

- * Note 4 revenue recognised over time
- * Note 9 fair value of unquoted investments
- * Note 10 impairment test of intangible assets and goodwill: key assumptions underlying recoverable amounts
- * Note 12 determination of fair value of investment property using significant unobservable inputs
- * Note 15 expected credit loss allowance on receivables

3. Seasonal operations

The group's businesses were not affected significantly by seasonal or cyclical factors during the financial period.

4. Segment and revenue information

The group is organised into the following main business segments:

- * Unifiedcomms Segment for content-driven mobile VAS, messaging and signaling systems, solutions and managed services.
- * GlobeOSS Segment for mobile network operation support systems, solutions and managed services.
- * Captii Ventures Segment for strategic investment in early and late-stage technology ventures.
- * Others Segment for investment holding and operational headquarters of the group.

These operating segments are reported in a manner consistent with internal reporting provided to those who are responsible for allocating resources and assessing performance of the operating segments.

4.2. Disaggregation of revenue

The group's revenue can be divided into revenue generated from two types of contracts, as described below:

Unifiedcomms

- (a) System sales this refers to contracts that involve the outright purchase by customers of systems comprising the group's products and technologies, and where these systems are in turn delivered as turnkey solutions. The scope of work for a system sale contract includes system design, implementation, testing and commissioning services.
- (b) Managed services this refers to contracts that involve the provision of both systems comprising the group's products and technologies as well as the group's professional services, on a recurring, revenue sharing, software as-a-service, pay-per-use or monthly or quarterly fixed and variable fee basis. Also treated as managed service contracts are system maintenance and technical support contracts with existing customers of the group.

Goodwill acquired through business combination had been allocated to its subsidiaries, Unified Communications Pte Ltd, Postpay Asia Sdn Bhd, Postpay Sdn Bhd, Postpay Technology Sdn Bhd, Adzentrum Sdn Bhd, Unified Communications (Private) Limited and Ahead Mobile Sdn Bhd for the purpose of impairment testing. The carrying amount is disclosed above.

An assessment is made annually whether goodwill has suffered any impairment loss based on the recoverable amount of the cash generating unit ("CGU"). The assessment process is complex and highly judgmental and is based on assumptions that are affected by expected future market or economic conditions. Judgement is required in identifying the CGU and the use of estimates as disclosed above. Actual outcomes could vary from these estimates.

The value-in-use was determined by management using a discounted cash flow valuation technique. The key assumptions for the value-in-use calculations are as follows. 1. Review

The condensed consolidated statement of financial position of Captii Limited and its subsidiaries as at 30 September 2025 and the related condensed consolidated profit or loss and other comprehensive income, condensed consolidated statement of changes in equity and condensed consolidated statement of cash flows for the financial period ended and certain explanatory notes have not been audited or reviewed.

2. Review of performance of the group

2.1 Review of performance of the group for the third quarter ended 30 September 2025 as compared to corresponding quarter ended 30 September 2024

Group revenue

The group recorded consolidated revenue of S\$3.699 million for the quarter ended 30 September 2025 ("Q3 2025"), a decrease of 23.6% against the revenue recorded in the corresponding quarter ended 30 September 2024 ("Q3 2024"). The decline in group revenue for Q3 2025 is attributable to the lower revenue performance recorded by both GlobeOSS and Unifiedcomms.

GlobeOSS recorded revenue of S\$1.258 million in Q3 2025, a decrease of 40.5% from the S\$2.116 million recorded in Q3 2024. This decrease in revenue was due to lower system sale contract and managed service contract revenues.

Unifiedcomms recorded revenue of S\$2.427 million in Q3 2025, a decrease of 10.9% from the S\$2.723 million recorded in Q3 2024. This decrease in revenue was due to lower managed service contract revenues.

The group's sales mix in Q3 2025 showed an increase in the proportionate contribution of revenue of a recurring nature, with revenue from managed service contracts representing 66.1% of the group's total revenue in Q3 2025, compared to 61.1% in Q3 2024. This shift was mainly due to a 33.5% drop in system sale contract revenues of GlobeOSS, from S\$1.885 million in Q3 2024 to S\$1.254 million in Q3 2025.

Group gross profit and gross profit margins

With the lower revenue recorded in Q3 2025, the group recorded a lower gross profit of \$\$2.3 million, a decrease of 20.1% from \$\$2.879 million realised in Q3 2024. Gross profit margin, however was higher at 62.2%, compared to 59.5% in Q3 2024, driven by the improvements in gross profit margin of both managed service contract and system sale contract revenues.

The gross profit margin on managed service contract revenues increased to 53% in Q3 2025, from 48.1% in Q3 2024. This improvement was primarily due to a lower revenue contribution from certain lower-margin managed service contracts.

The gross profit margin on system sale contract revenues also increased to 80.1% in Q3 2025, from 77.3% in Q3 2024. This increase is mainly attributable to a lower proportionate contribution of system sale contract revenues from GlobeOSS, which typically yields a lower gross profit margin due to higher third-party costs.

Interest income

The group recorded interest income of \$\$0.022 million in Q3 2025, slightly higher than the \$\$0.021 million recorded in Q3 2024.

Other gains and other item of expense

The group recorded net total expenses of S\$2.337 million in Q3 2025, a decrease of 67.3% from S\$7.131 million in Q3 2024. This decrease was mainly due to:-

- * Absence of fair value loss assessed on the group's venture investment portfolio in Q3 2025, compared to a loss of S\$4.465 million recorded in Q3 2024; and
- * Higher net foreign exchange gain, resulting from favourable exchange rate movements of the USD against the SGD, the group's reporting currency.

This improvement was partly offset by higher technical support and distribution expenses, arising from an increase in headcount at GlobeOSS.

Net profit/(loss) and EBITDA/(LBITDA)

The group recorded a net loss of \$\$0.14 million and EBITDA of \$\$0.148 million in Q3 2025, compared to a net loss of \$\$4.351 million and LBITDA of \$\$4.029 million in Q3 2024. The improvement in Q3 2025 is mainly attributable to the positive flow-down effects of higher gross profit margin and lower net total expenses.

2. Review of performance of the group

2.2 Review of performance of the group for the nine months ended 30 September 2025 as compared to corresponding financial period ended 30 September 2024

Group revenue

The group achieved consolidated revenue of S\$11.599 million for the nine months ended 30 September 2025 ("9M 2025"), a slight increase of 1.9% against the revenue recorded in the corresponding period ended 30 September 2024 ("9M 2024"). The increase in group revenue for 9M 2025 is attributable to the improved revenue performance by GlobeOSS.

GlobeOSS posted revenue of S\$4.312 million in 9M 2025, an increase of 14.3% from the S\$3.774 million recorded in 9M 2024. This improvement was driven by higher system sale contract revenues.

In contrast, Unifiedcomms recorded revenue of S\$7.257 million in 9M 2025, a decrease of 4.6% from the S\$7.609 million recorded in 9M 2024. This decrease was due to lower managed service contract revenues.

The group's sales mix in 9M 2025 showed a decrease in the proportionate contribution of revenue of a recurring nature, with revenue from managed service contracts representing 66.3% of the group's total revenue in 9M 2025, compared to 76.1% in 9M 2024. This shift was mainly due to a 43.4% increase in system sale contract revenues of both GlobeOSS and Unifiedcomms, from \$\$2.723 million in 9M 2024 to \$\$3.905 million in 9M 2025.

Gross profit and gross profit margins

The group posted gross profit of S\$7.18 million in 9M 2025, an increase of 17.4% from the S\$6.114 million recorded in 9M 2024. Gross profit margin also improved to 61.9% in 9M 2025, from 53.7% in 9M 2024, driven by the improvement in gross profit margin on managed service contract revenues.

The gross profit margin on managed service contract revenues increased to 53.9% in 9M 2025, from 45.4% in 9M 2024. This improvement was primarily due to a lower revenue contribution from certain lower-margin managed service contracts.

However, the gross margin improvement from managed service contract revenues was partly offset by the lower gross profit margin on system sale contract revenues, which decreased to 77.6% in 9M 2025, from 80% in 9M 2024. This decrease is mainly attributable to the higher proportionate contribution of system sale contract revenues from GlobeOSS, which typically yields a lower gross profit margin due to higher third-party costs.

Interest income

The group recorded interest income of \$\$0.061 million in 9M 2025, slightly lower than \$\$0.066 million recorded in 9M 2024.

Other gains and other item of expense

The group recorded net total expenses of \$\$7.283 million in 9M 2025, a decrease of 44.6% from \$\$13.139 million incurred in 9M 2024. This decrease was mainly due the absence of fair value loss on the group's venture investment portfolio in 9M 2025, compared to a loss of \$\$6.388 million recorded in 9M 2024.

This improvement was partly offset by higher technical support and distribution expenses, resulting from an increase in headcount at GlobeOSS.

Net loss and LBITDA

The group recorded a net loss of S\$0.327 million and EBITDA of S\$0.482 million in 9M 2025, compared to a net loss of S\$7.215 million and LBITDA of S\$6.352 million in 9M 2024. The improvement in 9M 2025 is mainly attributable to the combined effects of higher revenue, higher gross profit margin, and lower net total expenses.

2.3 Review of the group's financial position as at 30 September 2025 as compared to the group's financial position as at 31 December 2024

Non-cash current assets of the group decreased from S\$14.292 million as at 31 December 2024 to S\$9.866 million as at 30 September 2025, reflecting a decline of 30.9%. This decrease was mainly due to decrease in trade and other receivables arising from higher collections. In addition, other financial assets decreased, primarily attributable to lower contract assets and costs related to uncompleted revenue projects.

Total non-current assets of the group decreased marginally by 1.1%, from \$\$15.981 million as at 31 December 2024 to \$\$15.801 million as at 30 September 2025.

Total liabilities of the group decreased from \$\$4.994 million as at 31 December 2024 to \$\$3.08 million as at 30 September 2025, reflecting a reduction of 38.3%. This decrease was primarily due to lower trade and other payables, as well as reduced borrowings following repayments made during the reporting period.

2.4 Review of the group's cash flow for the quarter and nine months ended 30 September 2025 as compared to the corresponding quarter ended 30 September 2024

The group's net cash flow from operations for Q3 2025 and 9M 2025 amounted to S\$1.354 million and S\$4.144 million respectively, as compared to S\$0.86 million and S\$0.339 million for Q3 2024 and 9M 2024 respectively. The positive cash flow from operations was primarily due to higher favourable change in working capital of S\$1.218 million and S\$3.674 million for Q3 2025 and 9M 2025, compared to S\$0.424 million and S\$0.303 million for Q3 2024 and 9M 2024 respectively.

The group's net cash flow used in investing activities for Q3 2025 was S\$0.121 million, as compared to S\$0.458 million recorded in Q3 2024. The lower net cash used in investing activities was mainly due to lower investment in intangible assets and the absence of venture investments during the quarter.

The group's net cash flow used in investing activities for 9M 2025 was S\$0.379 million, as compared to S\$0.243 million recorded in 9M 2024. The higher net cash used in investing activities was mainly due the absence of proceeds from the disposal of a venture investment recorded in the prior period.

The group's net cash flow used in financing activities for Q3 2025 was S\$0.105 million, as compared to S\$0.182 million recorded in Q3 2024. The lower net cash used in financing activities was mainly due to lower repayments of borrowings during the quarter. Meanwhile, the group's net cash flow in financing activities for 9M 2025 was consistent with that of 9M 2024.

4. A commentary at the date of the announcement of the significant trends and competitive conditions of the industry in which the group operates and any known factors or events that may affect the group in the next reporting period and the next 12 months.

The outlook of Unifiedcomms and GlobeOSS remains challenging. The continued underperformance of certain major managed service contracts, intensified pricing pressures, and delays in securing new opportunities are expected to affect the business in the current financial year. However, significant steps have been taken since the previous financial year to strengthen the group's fundamentals.

On the business front, Unifiedcomms and GlobeOSS will continue to progress with contracts in-hand, reinvest in product innovation and market diversification, and focus on enhancing operational efficiencies.

At Captii Ventures, the group's venture investment business, broader market conditions remain unfavorable, though improvement is foreseen for start-ups in certain industries.

With continued fiscal discipline and initiatives aimed to strengthen the group's fundamentals, we remain cautiously optimistic about the remainder of the current financial year.
